The State of Idaho, Department of Finance, Securities Bureau (Department) and THE BABCO GROUP, LLC and ROBERT FISCHER, JR., parties to the above-captioned action, having agreed to resolve all allegations set forth in the Verified Complaint filed in the above-captioned action by the Stipulation for Entry of Judgment on file herein,

NOW, THEREFORE, THE COURT HEREBY FINDS that the Defendants have violated § 30-1403 of the Idaho Securities Act and § 30-14-501(2) of its successor act, the Uniform Securities Act (2004) (referred to collectively hereafter as “the Act”), by misrepresenting and omitting material facts in connection with the offer or sale of securities.

Further, THE COURT HEREBY ADJUDGES, ORDERS, AND DECREES as follows:

INJUNCTIVE RELIEF:

Defendants THE BABCO GROUP, LLC and ROBERT FISCHER, JR. are permanently enjoined, pursuant to Idaho Code § 30-14-603(b)(1), from engaging in any omissions and misrepresentations that would constitute violations of the Act, and in particular, that they be permanently enjoined from, while engaged in or in connection with the offer, sale or purchase of any security, making any untrue statement of a material fact or omitting to state a material fact necessary in order to make the statements made, in light of the circumstances under which they were made, not misleading.

MONEY JUDGMENT:

The Department is hereby awarded a money judgment against Defendants THE BABCO GROUP, LLC and ROBERT FISCHER, JR. in the total amount of \$17,876.82, constituting restitution and statutory interest for the victims of the Defendants’ violations of the Act.


