BASED ON THE FOREGOING, THE DIRECTOR HEREBY ORDERS that Idaho Mortgage Loan Originator License No. MLO-12214 issued to BRIAN ANTHONY LIMA is HEREBY TERMINATED, EFFECTIVE IMMEDIATELY. Such termination does not constitute a revocation of the license.

NOTICE

This Order is a Final Order of the Director. In accordance with Idaho Code § 67-5246, the Respondent is hereby notified of his right to file with the Idaho Department of Finance (Department) a motion for reconsideration of this order within fourteen (14) days of the issuance of this order. The motion for reconsideration shall be served on:

Any hearing and subsequent proceedings in this matter will be conducted in accordance with the Idaho Administrative Procedure Act, Idaho Code § 67-5201 *et seq.*

If the Respondent timely files a motion for reconsideration, the Department will dispose of such motion within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law, pursuant to Idaho Code § 67-5246(4).

If a hearing is held on the Respondent's motion for reconsideration, the Respondent will be notified of the date, time, and place of the hearing, as well as the name of the presiding officer. At such hearing, the Respondent will be entitled to enter an appearance, introduce evidence, examine and cross-examine witnesses, make arguments, and generally participate in the conduct of the proceedings. The Respondent may also be represented by legal counsel at his own expense.

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal from such order to the district court by filing a petition in the district court of the county in which:

- a. a hearing was held;
- b. the final agency action was taken;
- c. the party seeking review of the order resides; or
- d. the real property or personal property that was the subject of the agency action is located.


An appeal must be filed within twenty-eight (28) days: (a) of the issuance of this Order, or (b) of the issuance of an order denying a motion for reconsideration in the event such motion is made. Idaho Code § 67-5273(2). The filing of an appeal to the district court does not itself stay the effectiveness of enforcement of the order being appealed.
