**DEFAULT JUDGMENT AND PERMANENT
INJUNCTION REGARDING DEFENDANT
KA INVESTMENTS, INC.**

JUDGMENT IS ENTERED AS FOLLOWS:

1. Defendant KA Investments, Inc. will, jointly and severally with Defendant Rodney Allen, pay to Plaintiff the amount of three million nine hundred seventy-one thousand eight hundred six dollars (\$3,971,806), which Plaintiff is to use to make restitution to investors, pursuant to Idaho Code § 30-14-603(b)(2)(C). Plaintiff may pay costs associated with collecting and distributing the restitution out of these funds. These funds will not become the property or an asset of the Plaintiff.

2. That Defendant KA Investments, Inc. pay Plaintiff the amount of forty thousand dollars (\$40,000), which amount constitutes civil penalties, pursuant to Idaho Code § 30-14-603(b)(2)(C).

3. That Plaintiff is hereby awarded a money judgment against Defendant KA Investments, Inc., jointly and severally with Defendant Rodney Allen, in the amount of four million eleven thousand eight hundred six dollars (\$4,011,806), which sum includes and is the total of the awards for restitution and penalties.

4. That Defendant KA Investments, Inc. is permanently enjoined from engaging in any act or practice violating any provisions of Idaho's Uniform Securities Act (2004), Idaho Code § 30-14-101 *et seq.*, or any rule promulgated thereunder, pursuant to Idaho Code § 30-14-603(b)(1), and in particular, that they are permanently enjoined from selling or offering for sale securities in any form in the state of Idaho.


