STIPULATION FOR JUDGMENT AND PERMANENT INJUNCTION

The Defendants further agree that all advertising materials, as defined in Rule 010., will be reviewed and approved by counsel retained by Defendants, as conforming to Rule 010.04., prior to their use.
- 7. Said Judgment and Permanent Injunction shall constitute a final resolution of all issues presented in Plaintiff's complaint as to the Defendants, and may be presented to the Court immediately or at any time convenient to the Court, without the necessity of findings of fact or conclusions of law or further pleadings or proceedings in this matter.
