JUDGMENT IS ENTERED AS FOLLOWS:

1. Defendant Matthew Eugene Blood will pay to Plaintiff the amount of one hundred thirty thousand dollars (\$130,000), which Plaintiff is to use to make restitution to investors,


pursuant to Idaho Code § 30-14-603(b)(2)(C). Plaintiff may pay costs associated with collecting and distributing the restitution out of these funds. These funds will not become the property or an asset of the Plaintiff.

2. That Defendant Matthew Eugene Blood pay Plaintiff the amount of forty thousand dollars (\$40,000), which amount constitutes civil penalties, pursuant to Idaho Code § 30-14-603(b)(2)(C).

3. That Plaintiff is hereby awarded a money judgment against Defendant Matthew Eugene Blood in the amount of one hundred seventy thousand dollars (\$170,000), which sum includes and is the total of the awards for restitution, penalties and attorney fees.

4. That Defendant Matthew Eugene Blood is permanently enjoined from engaging in any act or practice violating any provisions of Idaho's Uniform Securities Act (2004), Idaho Code § 30-14-101 *et seq.*, or any rule promulgated thereunder, pursuant to Idaho Code § 30-14-603(b)(1), and in particular, that he is permanently enjoined from selling or offering for sale securities in any form in the state of Idaho.
