COME NOW the Plaintiff, by and through counsel, Earth Search Sciences, Inc., and Larry F. Vance (collectively the "Defendants"), by and through counsel, in order to avoid prolonged litigation, to stipulate and agree as follows:

- 1. The Complaint on file herein states a cause of action for injunctive relief against the Defendants.
- 2. The Defendants admit that they violated the Idaho Securities Act as alleged in the Complaint, only to the extent of Count One and Count Two, and neither admit nor deny the allegations in Count Three, Count Four, or Count Five.

- 3. The Defendants agree that the Judgment and Permanent Injunction attached hereto may be entered against them and hereby consent to the entry thereof.
- 4. Said Judgment and Permanent Injunction shall constitute a final resolution of all issues presented in or which could have been presented in Plaintiff's Complaint as to the Defendants, and may be presented to the Court immediately or at any time convenient to the Court, without the necessity of findings of fact or conclusions of law or further pleadings or proceedings in this matter. This Judgment and Permanent Injunction shall serve as a final resolution of all issues presented in or which could have been presented in Plaintiff's Complaint.
  - 5. Plaintiff agrees that it will seek no further remedies.
- 6. All stipulating parties shall bear their own attorneys' fees and costs of litigation.
