The State of Idaho, Department of Finance, Securities Bureau (Department) and Defendant Trevor Walker (Walker), parties to the above-captioned action, having agreed to resolve all allegations set forth in the Verified Complaint filed in the above-captioned action by the Stipulation and Consent to Entry of Judgment on file herein, which is incorporated herein by reference;

WHEREFORE, by virtue of the law and by reason of the premises aforesaid, THE COURT HEREBY ADJUDGES, ORDERS, AND DECREES as follows:

1. Pursuant to authority granted this court by Idaho Code § 30-14-603(b)(1), Walker is permanently enjoined from engaging in any act or practice that violates any provision of Idaho's Uniform Securities Act (2004), Idaho Code § 30-14-101 *et seq.*, or any rule promulgated thereunder.

2. Each party will bear its own attorney fees and costs in this action.
