**AMENDED MONEY JUDGMENT  
REGARDING DEFENDANTS JAMES  
CATLEDGE, IMPACT, INC., AND IMPACT  
NET WORTH, LLC**

On November 15, 2010, this Court entered its "Order Granting Plaintiff's Motion for Partial Summary Judgment Against Defendants James Catledge, Impact, Inc., and Impact Net Worth, LLC" (Order) in the above-captioned action.

Now, pursuant to such Order, THE COURT HEREBY FINDS that Defendants JAMES CATLEDGE, IMPACT, INC., and IMPACT NET WORTH, LLC violated Idaho's Uniform

Securities Act (2004), Idaho Code § 30-14-101 *et seq.*, as to Count Five of Plaintiff's Verified Complaint;

FURTHER, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

The Court hereby awards a money judgment to the State of Idaho, Department of Finance, Securities Bureau (Department), Plaintiff herein, to be paid by Defendants JAMES CATLEDGE, IMPACT, INC., and IMPACT NET WORTH, LLC, jointly and severally, in the total amount of two million four hundred six thousand two hundred thirty-three dollars and ninety-seven cents (\$2,406,233.97). Such total money judgment amount includes the following:

1. Rescission payable to Plaintiff in the amount of one million nine hundred eighty-two thousand four hundred six dollars and fifty-nine cents (\$1,982,406.59), pursuant to Idaho Code § 30-14-603(b)(2)(C). Plaintiff will forward rescission payments to investors who elected rescission.

2. Pre-judgment interest in the amount of four hundred thirteen thousand eight hundred twenty-seven dollars and thirty-eight cents (\$413,827.38), pursuant to Idaho Code § 30-14-603(b)(2)(D).

3. A penalty payable to Plaintiff in the amount of ten thousand dollars (\$10,000) for violating the Consent Order to Cease and Desist, pursuant to Idaho Code § 30-14-603(b)(2)(C).
