**JUDGMENT AND PERMANENT INJUNCTION AS
TO DEFENDANT CHAD LONGSON**

JUDGMENT IS ENTERED AS FOLLOWS:

Against Defendant Chad Longson.

**I.
PERMANENT INJUNCTION**

1. Defendant Chad Longson is permanently enjoined from engaging in any act or practice that violates any provision of Idaho's Uniform Securities Act (2004) or any rule promulgated thereunder, pursuant to authority granted this court by Idaho Code § 30-14-

603(b)(1). Defendant Chad Longson is permanently enjoined from issuing, offering, or selling securities in any form in or from the state of Idaho.

II.

MONEY JUDGMENT

2. Plaintiff is awarded a money judgment against Defendant Chad Longson in the amount of \$35,833.72, to be paid to Plaintiff (subject to the terms of the Stipulation and Consent to Entry of Judgment as to Defendant Chad Longson filed in this matter) and to be returned, in amounts to be determined by Plaintiff in its reasonable discretion, as restitution to the persons, or their estates, who invested with the Defendant as outlined in paragraphs 23-36 of the Complaint in this case, pursuant to Idaho Code § 30-14- 603(b)(2)(C).

3. Plaintiff is additionally awarded civil penalties, pursuant to Idaho Code § 30-14- 603(b)(2)(C), against Defendant Chad Longson in the amount \$10,000. Defendant Longson has already paid the penalty amount, on March 15, 2022.

3. Each party will bear its own attorney fees and costs in this action.

4. Interest on this total money judgment amount of \$35,833.72 will accrue at the statutory judgment rate, except as agreed upon by Plaintiff and Defendant Longson in the previously filed Stipulation and Consent to Entry of Judgment.
