PERMANENT INJUNCTION

- 1. Defendant Richard "Rick" F. Guyon is permanently enjoined from engaging in any act or practice that violates any provision of Idaho's Uniform Securities Act (2004) or any rule promulgated thereunder, pursuant to authority granted this court by Idaho Code § 30-14-603(b)(1).
- **2.** Defendant Richard "Rick" F. Guyon is permanently enjoined from issuing, offering or selling securities in the State of Idaho.

II.

MONEY JUDGMENT

3. Plaintiff is awarded a money judgment against Defendant Richard "Rick" F. Guyon, in the total amount of two million two hundred twenty-three thousand four hundred fifty dollars (\$2,223,450), to be paid to Plaintiff to be returned, in amounts to be determined by Plaintiff in its reasonable discretion, as restitution to persons who invested with Defendant Guyon in this case, pursuant to Idaho Code § 30-14-603(b)(2)(C). This judgment will be discharged according to the terms of the Stipulation and Consent to Entry of Judgment executed by Plaintiff and Defendant Guyon on file in this action.

4. Each party will bear its own attorney fees and costs in this action.
