In this action, Defendant Theodore Sebastian Hauk, having been duly served with the Complaint and Summons on January 28, 2005, and Defendant Theodore Sebastian Hauk having failed to appear under I.R.C.P. 12(a), to plead or otherwise defend in this action, the legal time

for answering having expired, the Default of the Defendant Theodore Sebastian Hauk having been duly entered according to law, based upon the Affidavit of Joseph B. Jones, the pleadings and records on file herein, and pursuant to the prayer of Plaintiff's Verified Complaint,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that:

1. Defendant Theodore Sebastian Hauk has violated the Idaho Securities Act;
2. Defendant Theodore Sebastian Hauk is permanently enjoined from engaging in any acts, practices, courses of business, omissions, and misrepresentations which would constitute violations of the Idaho Securities Act, Title 30, Chapter 14, Idaho Code, and any other Idaho securities laws, rules, or regulations.
3. Defendant Theodore Sebastian Hauk is permanently enjoined from engaging in any of the following acts and conduct:

While engaged in or in connection with the offer, sale or purchase of any security:

- a. Employing any device, scheme or artifice to defraud any investors or prospective investors;
 - b. Making any untrue statement of a material fact or omitting to state a material fact necessary in order to make the statements made, in light of the circumstances under which they are made, not misleading;
 - c. Engaging in any act, practice or course of business which operates or would operate as a fraud or deceit upon any person.
4. Defendant Theodore Sebastian Hauk is prohibited from claiming the availability of, using, or offering or selling securities under any exemptions under the Idaho

Securities Act, or any other Idaho securities laws, rules, or regulations, without receiving the prior written consent of the Director of the Idaho Department of Finance.

5. Plaintiff is awarded a money judgment against Defendant Theodore Sebastian Hauk in the following amounts:

a. \$40,000.00, representing penalties against the Defendant, pursuant to Idaho Code § 30-1442(3)(b);

b. \$12,115.00, representing restitution to the investors named in the Complaint filed in this case, pursuant to Idaho Code § 30-1442(3)(a);

c. \$1,500.00, representing the Plaintiff's reasonable attorneys fees incurred, and \$1,000.00, representing the Plaintiff's costs of investigation, pursuant to Idaho Code § 30-1442(3)(c);

for a **TOTAL JUDGMENT** in the amount of **\$54,615.00**.
