Judgment is entered as follows:

I.

#### **PERMANENT INJUNCTION**

1. Defendant Jeffrey Grant Jerome (Jerome) is permanently enjoined from engaging in

any act or practice that violates any provision of Idaho's Uniform Securities Act (2004) or any

rule promulgated thereunder, pursuant to authority granted this court by Idaho Code § 30-14-603(b)(1).

2. Jerome is permanently enjoined from issuing, offering or selling securities in the State of Idaho.

### II.

#### **MONEY JUDGMENT**

3. Plaintiff is awarded a money judgment against Defendant Jeffrey Grant Jerome in the total amount of one hundred fifty-two thousand six hundred seventy-six dollars (\$152,676), to be paid to Plaintiff to be returned, in amounts to be determined by Plaintiff in its reasonable discretion, as restitution to persons who invested with the Defendant as outlined in the Verified Complaint in this case, pursuant to Idaho Code § 30-14-603(b)(2)(C).

4. Each party will bear its own attorney fees and costs in this action.
