The State of Idaho, Department of Finance, Securities Bureau (Plaintiff) and Defendant Luke Lowell (Defendant), parties to the above-captioned action, having agreed to resolve all allegations set forth in the Amended Verified Complaint filed in the above-captioned action by the Stipulation and Consent to Entry of Judgment Regarding Defendant Lowell on file herein,

WHEREFORE, by virtue of the law and by reason of the premises aforesaid, THIS COURT HEREBY ADJUDGES, ORDERS, AND DECREES as follows:

1. Plaintiff is hereby awarded a money judgment against Defendant Luke Lowell in the total amount of three hundred thirteen thousand six hundred eighty-six dollars and eighty-three cents (\$313,686.83), which is to be paid to Plaintiff to be returned by Plaintiff as restitution to persons who invested with Defendant Dale Lowell in this case, pursuant to Idaho Code § 30-14-603(b)(2)(C).

2. Each party will bear its own attorney fees and costs in this action.
