JUDGMENT


Pursuant to this court's Order entered herein, which grants partial summary judgment to the Plaintiff based on Count One of Plaintiff's Verified Complaint To Determine Dischargeability Of Judgment, and good cause appearing therefore,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED, pursuant to 11 USC § 523(a)(19), that the Amended Default Judgment entered by the Bonneville County, Idaho, District Court on March 25, 2003, by the Honorable Gregory S. Anderson, in Bonneville County Case No. CV-02-7169, is not dischargeable in Defendant Robert O. McClung's pending bankruptcy proceeding, Bankruptcy Case No. 03-40682, nor may that Amended Default Judgment be discharged in any subsequent bankruptcy case filed by Robert O. McClung.




