SATISFICATION OF JUDGMENT



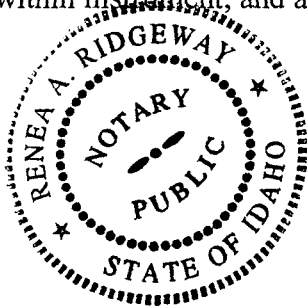


