IT IS HEREBY ORDERED that:

- 1. Plaintiff's motion for partial summary judgment against Defendants Wilcox, Harris and Sellers as to Count One, and against Defendant Sellers as to Count Two is GRANTED.
- 2. Plaintiff's motion for partial summary judgment against Defendants Wilcox, Harris and Sellers as to Counts Three and Five, and against Defendants Wilcox and Harris as to Count Four is DENIED.
- 3. During the pendency of this action, or until its final determination, or until the Court shall otherwise order, Defendants Wilcox, Harris and Sellers are temporarily enjoined from selling or offering for sale investments in PCO, Inc., aka Personal Choice Opportunities, in the State of Idaho.
- 4. During the pendency of this action, or until its final determination, or until the Court shall otherwise order, Defendant Sellers is temporarily enjoined from transacting securities business

in the State of Idaho while not registered as a salesman with the Idaho Department of Finance, in accordance with Title 30, Chapter 14, Idaho Code.
