On October 25, 2002 the Court entered Partial Summary Judgment as to Liability against the above named Defendants, establishing that the Defendants have violated the Idaho Securities Act as alleged in the Verified Complaint on file herein. Subsequently, the Plaintiff filed a motion for summary judgment against Defendant Charles H. Michel (Michel), seeking judgment against

Michel as to penalties, restitution and attorney's fees. Based upon the record and the file herein, the Court finds that Defendant Michel has violated the Idaho Securities Act as alleged in the Verified Complaint on file herein and that the Plaintiff is entitled to judgment as a matter of law.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED
as follows:

INJUNCTIVE RELIEF

The Defendant Charles H. Michel is permanently enjoined from engaging in any acts, practices or omissions which would constitute violations of the Idaho Securities Act, Title 30, Chapter 14, Idaho Code, and in particular, the Defendants are permanently enjoined from:

- A. Selling or offering for sale nonexempt securities in any form in the State of Idaho until such time as the securities have been registered with the Idaho Department of Finance in accordance with Title 30, Chapter 14, Idaho Code;
- B. Selling or offering for sale nonexempt securities in any form in the State of Idaho until such time as the Defendant Charles H. Michel has registered as a broker-dealer or salesman for a broker-dealer or issuer with the Idaho Department of Finance, in accordance with Title 30, Chapter 14, Idaho Code;
- C. While engaged in or in connection with the offer, sale or purchase of any security:
 - (1) Employing any device, scheme or artifice to defraud any investors in the securities;
 - (2) Making any untrue statement of a material fact or omitting to state a material fact necessary in order to make the statements made, in

light of the circumstances under which they are made, not misleading;

- (3) Engaging in any act, practice or course of business which operates or would operate as a fraud or deceit upon any person.
- (4) Aiding, abetting, counseling, inducing or causing any other person to engage in any of the types of conduct described in paragraphs (C)(1), (C)(2), or (C)(3) above.

The Defendant Charles H. Michel is further prohibited from claiming the availability of, using, or offering or selling securities, under any exemptions under the Idaho Securities Act without receiving the prior written consent of the Director of the Idaho Department of Finance.

MONEY JUDGMENT

The Plaintiff is hereby awarded a money judgment against Defendant Charles H. Michel in the total amount of \$100,335.00, which includes \$45,335.00 as restitution for the victims of Defendant Michel's violations of the Idaho Securities Act, pursuant to Idaho Code § 30-1442(3)(a), \$50,000 as a civil penalty pursuant to Idaho Code § 30-1442(3)(b), and \$5,000.00 in attorney's fees pursuant to Idaho Code § 30-1442(3)(c).
