PURSUANT TO THE AFOREMENTIONED STIPULATION, THE COURT HEREBY ORDERS, ADJUDGES AND DECREES as follows:

INJUNCTIVE RELIEF:

Defendant Jeffrey Dirk Roberts is permanently enjoined from engaging in any acts, practices or omissions which would constitute violations of the Idaho Securities Act, Title 30, Chapter 14, Idaho Code, or any successor act, and in particular, he is permanently enjoined from:

While engaged in or in connection with the offer, sale or purchase of any security

in the state of Idaho:

- (1) Employing any device, scheme, or artifice to defraud any investors or prospective investors, including specifically:
 - (a) borrowing money or securities from a customer unless the customer is a broker-dealer, an affiliate, or a financial institution engaged in the business of loaning funds or securities, or immediately family,
 - (b) misappropriating and converting client investment monies to his own use, and
 - (c) executing investment transactions which are unauthorized by customers; and
- (2) Engaging in any act, practice or course of business which operates, or would operate, as a fraud or deceit upon any person, including specifically those acts listed in ¶(1)(a) through (c) above.

RESTITUTION:
Any restitution arising from this action shall be paid pursuant to the sentencing order
issued in Ada County Criminal Case No. H0400196.
