STIPULATION FOR ENTRY OF JUDGMENT

The Department and Roberts hereby stipulate and agree to the following terms and conditions in settlement of this matter:

(1) Roberts neither admits nor denies that he violated the Idaho Securities Act as alleged in Counts One through Three of the Verified Complaint filed by the Plaintiff in this action.

(2) Pursuant to Idaho Code § 30-1442(3), Roberts consents to the Court entering against him the injunction set forth in the Stipulated Judgment and Permanent Injunction, a copy of which is attached hereto as Exhibit A.

(3) Pursuant to Idaho Code § 30-1442(3)(a), Roberts agrees, without admitting or denying liability, that restitution arising from Roberts' alleged violations of the Idaho Securities Act in this action shall be paid pursuant to the sentencing order issued in Ada County Criminal Case No. H0400196.

(4) The Department agrees to forgo any claim for costs, attorney fees, and reimbursement for investigative efforts in this action pursuant to Idaho Code § 30-1442(3)(c), and also agrees to forgo any additional penalties against Roberts related to this action. Roberts agrees to bear all of his own attorney fees and costs related to this action.

- (b) misappropriating and converting client investment moniesto his own use, and
- (c) executing investment transactions which are unauthorized by customers; and

(2) Engaging in any act, practice or course of business which operates, or would operate, as a fraud or deceit upon any person, including specifically those acts listed in ¶ (1)(a) through (c) above.
