**STIPULATED JUDGMENT AND  
PERMANENT INJUNCTION**

The State of Idaho, Department of Finance, Securities Bureau (Department) and Defendant Tony Scott Sellers (Sellers), parties to the above-captioned action, having agreed to resolve all allegations set forth in the Complaint filed in the above-captioned action by the Stipulation and Consent to Entry of Judgment on file herein,

WHEREFORE, by virtue of the law and by reason of the premises aforesaid, THE COURT HEREBY ADJUDGES, ORDERS, AND DECREES as follows:

**I.  
PERMANENT INJUNCTION**

Sellers is permanently enjoined from engaging in any act or practice that violates any provision of Idaho's Uniform Securities Act or any rule promulgated thereunder, and is permanently enjoined from selling, offering for sale or issuing securities in any form in the state of Idaho, pursuant to authority granted this court by Idaho Code § 30-14-603(b)(1).

Sellers is further permanently enjoined from offering or selling any financial product in Idaho or to Idaho residents other than life, health or disability insurance offered by an insurance company registered or licensed with the Idaho Department of Insurance. Sellers may offer and sell an insurance or endowment policy or annuity contract under which an Idaho licensed or registered insurance company promises to pay money either in a lump sum or periodically for life or other specified period.

**II.  
MONEY JUDGMENT**

The Department is hereby awarded a money judgment against Sellers in the total amount of twenty thousand dollars (\$20,000) as authorized by Idaho Code § 30-14-603(2)(C).

Each party will bear its own attorney fees and costs in this action. The Court will retain jurisdiction over this matter for five (5) years from the date of issuance, for the purpose of enforcing any breach of the Stipulation and Consent to Entry of Judgment.
