JUDGMENT IS ENTERED AS FOLLOWS:

Against Defendants Nathan Ward Pyles ("Pyles") and Shiloh Management Services, Inc. ("Shiloh").

i. PERMANENT INJUNCTION

1. Pyles and Shiloh are permanently enjoined from engaging in any act or practice

that violates any provision of Idaho's Uniform Securities Act (2004) or any rule promulgated thereunder, pursuant to authority granted this court by Idaho Code§ 30-14-603(b)(1).

2. Pyles and Shiloh are permanently enjoined from engaging in the offer or sale of securities in any form in the state of Idaho.

II.

MONEY JUDGMENT

- 3. Plaintiff is awarded a money judgment against Defendants Pyles and Shiloh in the total amount of \$9,574,708.24, it being understood that the judgment amount will be effectively reduced and partially satisfied as described in the Order Granting Plaintiff's Motion for Summary Judgment, and to the extent of any amounts paid to Plaintiff and then to be returned, in amounts to be determined by Plaintiff in its reasonable discretion, as restitution to the persons who invested with the Defendants, pursuant to Idaho Code § 30-14-603(b)(2)(C).
 - 5. Each party will bear its own attorney fees and costs in this action.
