NOW, THEREFORE, THE COURT HEREBY FINDS that Defendants WISE ENTERPRISES, LLC and WISE LENDING, LLC have violated Idaho's Uniform Securities Act (2004), Title 30, Chapter 14, Idaho Code, as alleged in Counts One through Five of the Plaintiff's Complaint filed in the above-captioned matter.

FURTHER, the Court hereby ORDERS, ADJUDGES AND DECREES as follows:

INJUNCTIVE RELIEF

Defendants WISE ENTERPRISES, LLC and WISE LENDING, LLC are permanently enjoined from engaging in any acts or practices which would constitute violations of any provision of Idaho's Uniform Securities Act (2004), pursuant to Idaho Code § 30-14-603(b)(1).

MONEY JUDGMENT

FURTHER, the Court HEREBY awards a money judgment to the Department to be paid by Defendants WISE ENTERPRISES, LLC and WISE LENDING, LLC, jointly and severally, in the total amount of two million, four hundred forty-three thousand, six hundred thirty-six dollars and seventy-nine cents (\$2,443,636.79).

Such money judgment amount includes restitution in the amount of two million, two hundred seventy-six thousand, six hundred thirty-six dollars and seventy-nine cents (\$2,276,636.79) payable to the Department by such Defendants on behalf of persons injured by the Defendants' violations of the Idaho's Uniform Securities Act (2004), Idaho Code § 30-14-101 *et seq*. Such money judgment amount also includes penalties payable to the Department by such Defendants in the amount of one hundred sixty thousand dollars (\$160,000.00) as authorized by § 30-14-603(2)(C) of Idaho's Uniform Securities Act (2004).
