STIPULATED JUDGMENT AND PERMANENT INJUNCTION

The State of Idaho, Department of Finance, Securities Bureau (Department) and Defendant Gerald Richard Thompson, an individual and Sky Detective, Inc. (Thompson), parties to the above-captioned action, having agreed to resolve all allegations set forth in the Verified Complaint filed in the above-captioned action by the Stipulation and Consent to Entry of Judgment on file herein,

WHEREFORE, by virtue of the law and by reason of the premises aforesaid, THE COURT HEREBY ADJUDGES, ORDERS, AND DECREES as follows:

## I. PERMANENT INJUNCTION

Thompson is permanently enjoined from engaging in any act or practice that violates any provision of Idaho's Uniform Securities Act or any rule promulgated thereunder, pursuant to authority granted this court by Idaho Code § 30-14-603(b)(1). Thompson is also permanently enjoined from selling or offering for sale securities in any form in the state of Idaho.

## II. MONEY JUDGMENT

The Department is hereby awarded a money judgment against Thompson in the total amount of three million six hundred sixty-nine thousand one hundred fifty dollars (\$3,669,150), to be paid according to terms of the Stipulation and Consent to Entry of Judgment (Stipulation) executed by Thompson and the Department. Those terms are incorporated herein by reference and specifically declare that Thompson shall bear no obligation to pay the any portion of this Judgment over and above thirty thousand dollars (\$30,000.00) unless he defaults upon and/or breaches the terms of the parties' Stipulation.

Such money judgment amount includes restitution in the amount of three million six hundred twenty-nine thousand one hundred fifty dollars (\$3,629,150), which is to be paid to the Department for the ministerial function of being returned as restitution to persons who invested with Thompson in this case, pursuant to Idaho Code § 30-14-603(b)(2)(C). Restitution payments received pursuant to this judgment shall not become assets of the Department.

Such money judgment amount further includes penalties payable to the Department by Thompson in the amount of forty thousand dollars (\$40,000) as authorized by Idaho Code § 30-14-603(2)(C).

Each party will bear its own attorney fees and costs in this action. The Court will retain jurisdiction over this matter for ten (10) years from the date of issuance, for the purpose of enforcing a breach of the Stipulation and Consent to Entry of Judgment.
