STIPULATED JUDGMENT AND PERMANENT INJUNCTION

Defendant Shane Michael Turner (Turner) and the Department of Finance, State of Idaho,

Securities Bureau (Department), Plaintiff herein, having agreed to resolve all allegations set forth

in the Verified Complaint filed in the above-captioned action by the Stipulation on file herein,

PURSUANT TO THE AFOREMENTIONED STIPULATION, THE COURT HEREBY ORDERS, ADJUDGES AND DECREES as follows:

#### **INJUNCTIVE RELIEF:**

Defendant Shane Michael Turner is permanently enjoined from engaging in any acts, practices, or courses of business which would constitute violations of the Uniform Securities Act (2004) (the Act) and rules promulgated thereunder, and in particular, he is permanently enjoined from:

- (A) Selling or offering for sale nonexempt securities in any form in the state of Idaho until such time as the securities have been registered with the Idaho Department of Finance in accordance with the Act;
- (B) Selling or offering for sale nonexempt securities in any form in the state of Idaho until such time as Turner has properly registered with the Idaho Department of Finance in accordance with the Act;
- (C) While engaged in or in connection with the offer, sale, or purchase of any security:
  - Employing any device, scheme, or artifice to defraud any investors or prospective investors;
  - (2) Making any untrue statement of a material fact or omitting to state a material fact necessary in order to make the statements made, in light of the circumstances under which they are made, not misleading;
  - (3) Engaging in any act, practice, or course of business which operates or would operate as a fraud or deceit upon any person;

- (4) Aiding, abetting, counseling, inducing, or causing any other person to engage in any of the types of conduct described in paragraphs (C)(1), (C)(2), or (C)(3) above; and
- (5) Claiming the availability of, using, or offering or selling securities under any exemption under the Uniform Securities Act (2004) or rules promulgated thereunder without receiving the prior written consent of the Director.

#### MONEY JUDGMENT:

Defendant Turner is ordered to pay to the Department the amount of \$114,200 in restitution for distribution to injured investors. If Defendant Turner makes restitution satisfactory to the court in Ada County Criminal Case No. H0601321, this judgment for restitution shall be satisfied.
